Truth Against the World

Despite the renewed interest in Frank Lloyd Wright and the increasing body of literature that has illuminated his career, the deeper meaning of his architecture continues to be elusive. His own writings are often interesting commentaries but tend not to enlighten us as to his design methodology, and it is difficult to make the connection between his stated philosophy and his actual designs. Book Description: Frank Lloyd Wright's mammoth contribution to architecture is universally acknowledged, but his graphic work has been largely overlooked in the existing literature about this seminal architect. His designs for typography, books, posters, murals, and magazines have remained relatively obscure, even though they are key components of his oeuvre. Penny Fowler has thoroughly investigated the artist's innovative graphic work and placed it within the context of various aesthetic movements, from Arts and Crafts to Bauhaus and De Stijl. Wright's publications - including The House Beautiful and An Autobiography - his delineations for the Wasmuth Portfolio, and his mural designs for Midway Gardens and the Imperial Hotel are explored, and one chapter is devoted to the festive covers Wright created for Liberty magazine. 50 Lessons to Learn from Frank Lloyd Wright

Born in Bear Valley, Wisconsin, raised in nearby Richland Center, then Massachusetts before settling in south central Wisconsin, Frank Lloyd Wright always knew that he would be an architect. He wanted to create a Democratic American Architecture. With his Prairie homes, he achieved the first part of his goal, American Architecture. It was based upon geometry, the cruciform/pinwheel and square. With his Usonian houses, he created the next part, Democratic, thus achieving Democratic American Architecture. This was achieved by reducing the Prairie cruciform to a simple L.It is not easy for most to visualize in three dimensions, especially when one must do so from a two-dimensional plan. Yet Wright could visualize his idea for a building in three dimensions before he drew it in two. Two plans that, on paper, look identical, might be hugely different, depending on scale. SIZE MATTERS. For the author of this book, William Allin Storrer, Ph.D., the ability to visualize in three dimensions came when he took special tests with the Detroit Board of Education. Supposedly difficult spatial problems he solved quickly. But this ability didn't come into focus until he was enrolled in his doctoral program. For an architectural seminar, he was required to draw the plan of a \"typical\" building of each era in modern architecture: Greek, Roman, Medieval, Renaissance . . . First the Parthenon, then the Pantheon. Each fit the 11 x 8 1/2 inch paper. Seeking a perfect Gothic work, he discovered the cathedral of Amiens, France, Notre Dame D'Amiens, constructed in less than fifty years, a perfect example of Gothic. By the time he'd drawn the upper half of the east end, he'd filled the paper. Had he visualized the entire work in three dimensions, the full size of the cathedral would have been apparent and he'd have used a larger paper rather than tape pages together! SIZE MATTERS. Thus this book includes American houses and apartment buildings, for it is devoted to \"the space within to be lived in,\" as Wright stated it. It is hoped that this will open new ways of envisioning Wright's monumental catalog of domestic works.

Between 1898 and 1909, Frank Lloyd Wright's residential studio in the idyllic Chicago suburb of Oak Park served as a nontraditional work setting as he matured into a leader in his field and formulized his iconic

design ideology. Here, architectural historian Lisa D. Schrenk breaks the myth of Wright as the lone genius and reveals new insights into his early career. With a rich narrative voice and meticulous detail, Schrenk tracks the practice's evolution: addressing how the studio fit into the Chicago-area design scene; identifying other architects working there and their contributions; and exploring how the suburban setting and the nearby presence of Wright's family influenced office life. Built as an addition to his 1889 shingle-style home, Wright's studio was a core site for the ideological development of the prairie house, one of the first truly American forms of residential architecture. Schrenk documents the educational atmosphere of Wright's office in the context of his developing design ideology, revealing three phases as he transitioned from colleague to leader. This heavily illustrated book includes a detailed discussion of the physical changes Wright made to the building and how they informed his architectural thinking and educational practices. Schrenk also addresses the later transformations of the building, including into an art center in the 1930s, its restoration in the 1970s and 80s, and its current use as a historic house museum. Based on significant original and archival research, including interviews with Wright's family and others involved in the studio and 180 images, The Oak Park Studio of Frank Lloyd Wright offers the first comprehensive look at the early independent office of one of the world's most influential architects.

Reiss presents the updated and detailed story of one of Wright's few Virginia commissions. Designed and built for Loren and Charlotte Pope and later purchased by Marjorie and Robert Leighey, the Pope-Leighey House stands as a stunning example of an innovative form of shelter--which Wright called Usonian--for families beset by the Great Depression. Here, and elsewhere, Wright offered a unique and unprecedented approach for homes that would be small yet architecturally significant, carefully sited, and constructed of readily available local materials. Wright's mission was to remind us that \"we need to see life in simpler terms.\" In this amply illustrated book, Reiss echoes Wright's reminder that small, carefully built structures should be the starting point of sustainable and environmentally responsible house design.

Insufficient Funds: The Financial Life of Frank Lloyd Wright By Peter C. Alexander Dozens of books have been written about architect Frank Lloyd Wright's architecture, aesthetic, and various design achievements; however, no one has looked at his business practices... until now. Years with Frank Lloyd Wright

In architectural terms, the twentieth century can be largely summed up with two names: Frank Lloyd Wright and Philip Johnson. Wright (1867–1959) began it with his romantic prairie style; Johnson (1906–2005) brought down the curtain with his spare postmodernist experiments. Between them, they built some of the most admired and discussed buildings in American history. Differing radically in their views on architecture, Wright and Johnson shared a restless creativity, enormous charisma, and an outspokenness that made each

man irresistible to the media. Often publicly at odds, they were the twentieth century's flint and steel; their repeated encounters consistently set off sparks. Yet as acclaimed historian Hugh Howard shows, their rivalry was also a fruitful artistic conversation, one that yielded new directions for both men. It was not despite but rather because of their contentious--and not always admiring--relationship that they were able so powerfully to influence history. In Architecture's Odd Couple, Howard deftly traces the historical threads connecting the two men and offers readers a distinct perspective on the era they so enlivened with their designs. Featuring many of the structures that defined modern space--from Fallingwater to the Guggenheim, from the Glass House to the Seagram Building--this book presents an arresting portrait of modern architecture's odd couple and how they shaped the American landscape by shaping each other.
