## **The Balkan Wars**

The history of the Balkans incorporates all the major historical themes of the 20th Century--the rise of

nationalism, communism and fascism, state-sponsored genocide and urban warfare. Although top-down 'Great Powers' historiography is often used to describe the beginnings of the World War I, not enough attention has been paid to the events in the region in the years preceding the Archduke Ferdinand's assassination. The Balkan Wars saw the defeat of the Ottoman Empire, the end of the Bulgarian Kingdom (then one of the most powerful military countries in the region), an unprecedented hardening of Serbian nationalism, the swallowing up of Slovenes, Croats and Slovaks in a larger Balkan entity, and thus set in place the pattern of border realignments which would become familiar for much of the twentieth century.

## **War in the Balkans**

Distinguished scholar James D. Tracy shows how the Ottoman advance across Europe stalled in the western Balkans, where three great powers confronted one another in three adjoining provinces: Habsburg Croatia, Ottoman Bosnia, and Venetian Dalmatia. Until about 1580, Bosnia was a platform for Ottoman expansion, and Croatia steadily lost territory, while Venice focused on protecting the Dalmatian harbors vital for its trade with the Ottoman east. But as Habsburg-Austrian elites coalesced behind military reforms, they stabilized Croatia's frontier, while Bosnia shifted its attention to trade, and Habsburg raiders crossing Dalmatia heightened tensions with Venice. The period ended with a long inconclusive war between Habsburgs and Ottomans, and a brief inconclusive war between Austria and Venice. Based on rich primary research and a masterful synthesis of key studies, this book is the first English-language history of the early modern Western Balkans. More broadly, it brings out how the Ottomans and their European rivals conducted their wars in fundamentally different ways. A sultan's commands were not negotiable, and Ottoman generals were held to a time-tested strategy for conquest. Habsburg sovereigns had to bargain with their elites, and it took elaborate processes of consultation to rally provincial estates behind common goals. In the end, government-by-consensus was able to withstand government-by-command.

## **Balkan Wars**

In the fall of 1912, the Ottoman Empire was in turmoil. In addition to the Albanian and the Yemen rebellions, the Empire was at war with Italy over the Libyan territory. Worse yet, cholera was spreading throughout the country, leaving a decimated population in its wake. In its weakness, the Ottoman Empire was ripe to be attacked, and the Balkan countries did so. On October 8, 1912, Montenegro declared war on the Ottoman Empire, beginning the first of the Balkan Wars. Embracing maturity and setting their differences aside, four nations joined together to form the Balkan League-Serbia, Greece, Montenegro, and Bulgaria. Despite the tremendous land victory celebrated by the Balkan League, disputes over dividing the won territory soon arose. Dissatisfied with its share of the Macedonia, Bulgaria attacked its former allies Serbia and Greece. On August 10, 1913, the Treaty of Bucharest ended the second conflict, but it did not bring the peace. In the First World War, which was initiated by Sarajevo assassination, Balkan again became theater of the war. The Balkan wars have been a popular topic for scholarly research since their resolution. Despite the attention this topic has received, however, the research is far from complete. In this study contributing to the documentation and understanding of this conflict, author Igor Despot has not only reviews the events of the wars, but also considers these events in light of pertinent cultural aspects, identifying the commonalities and differences that may have determined alliances or sparked conflict throughout Balkan history.

## **Building a Multiethnic Military in Post-Yugoslav Bosnia and Herzegovina**

Based on extensive new archival research, the book traces the gradual militarization of Austro-Hungarian foreign policy during the Balkan Wars. The disasters of those wars and the death of the Archduke Franz Ferdinand, the heir-apparent and a force for peace in the monarchy, convinced the Habsburg elite that only a war against Serbia would end the South Slav threat to the monarchy's existence. Williamson also describes Russia's assertive foreign policy after 1912 and stresses the unique linkages of domestic and foreign policy in almost every issue faced by Habsburg statesmen.

## **The Austro-Hungarian Army and the First World War**

Franz Josef I, emperor of Austria-Hungary, was the first European leader to declare war in 1914 and was the first to commence firing. Samuel Mozolak was a Slovak laborer who sailed to New York--and fathered twins, taken as babies (and U.S. citizens) to his home village--before being drafted into the Austro-Hungarian army and killed in combat. Mozolak's story depicts the life of a peasant in an army staffed by aristocrats, and also illustrates the pattern of East European immigration to America.

## **Crossroads of European Histories**

This edited volume focuses on the use of ‘necessary condition counterfactuals’ in explaining two key events in twentieth century history, the origins of the First World War and the end of the Cold War. Containing essays by leading figures in the field, this book analyzes the causal logics of necessary and sufficient conditions, demonstrates the variety of different ways in which necessary condition counterfactuals are used to explain the causes of individual events, and identifies errors commonly made in applying this form of causal logic to individual events. It includes discussions of causal chains, contingency, critical junctures, and ‘powder keg’ explanations, and the role of necessary conditions in each. *Explaining War and Peace* will be of great interest to students of qualitative analysis, the First World War, the Cold War, international history and international relations theory in general.

## **The Balkan Wars 1912-1913**

How and why did Britain become involved in the First World War? Taking into account the scholarship of the last twenty-five years, this second edition of Zara S. Steiner's classic study, thoroughly revised with Keith Neilson, explores a subject which is as highly contentious as ever. While retaining the basic argument that Britain went to war in 1914 not as a result of internal pressures but as a response to external events, Steiner and Neilson reject recent arguments that Britain became involved because of fears of an 'invented' German menace, or to defend her Empire. Instead, placing greater emphasis than before on the role of Russia, the authors convincingly argue that Britain entered the war in order to preserve the European balance of power and the nation's favourable position within it. Lucid and comprehensive, *Britain and the Origins of the First World War* brings together the bureaucratic, diplomatic, economic, strategic and ideological factors that led to Britain's entry into the Great War, and remains the most complete survey of the pre-war situation.

## **World War I**

Since the collapse of Eastern European communism, the Balkans have been more prominent in world affairs than at any time since before the First World War. Crises in the area have led NATO to fire its first ever shots in anger, whilst international forces have been deployed on a scale and in a manner unprecedented in Europe since World War Two. An understanding of why this happened is impossible without some knowledge of the history of the area before the fall of communism, of how the communists came to power and how they used their authority thereafter. Covering the communist states of Albania, Bulgaria, Romania and Yugoslavia, and including Greece, Richard Crampton provides a highly readable introduction to that history, one that will be read by journalists, diplomats and anyone interested in the region and its impact on world politics today.
