Is the EU Doomed?

The European Union is in crisis. Crippled by economic problems, political brinkmanship, and institutional rigidity, the EU faces an increasingly uncertain future. In this compelling essay, leading scholar of European politics, Jan Zielonka argues that although the EU will only survive in modest form - deprived of many real powers - Europe as an integrated entity will grow stronger. Integration, he contends, will continue apace because of European states' profound economic interdependence, historic ties and the need for political pragmatism. A revitalized Europe led by major cities, regions and powerful NGOs will emerge in which a new type of continental solidarity can flourish. The EU may well be doomed, but Europe certainly is not.

German Europe

The euro crisis is tearing Europe apart. But the heart of the matter is that, as the crisis unfolds, the basic rules of European democracy are being subverted or turned into their opposite, bypassing parliaments, governments and EU institutions. Multilateralism is turning into unilateralism, equality into hegemony, sovereignty into the dependency and recognition into disrespect for the dignity of other nations. Even France, which long dominated European integration, must submit to Berlin's strictures now that it must fear for its international credit rating. How did this happen? The anticipation of the European catastrophe has already fundamentally changed the European landscape of power. It is giving birth to a political monster: a German Europe. Germany did not seek this leadership position - rather, it is a perfect illustration of the law of unintended consequences. The invention and implementation of the euro was the price demanded by France in order to pin Germany down to a European Monetary Union in the context of German unification. It was a quid pro quo for binding a united Germany into a more integrated Europe in which France would continue to play the leading role. But the precise opposite has happened. Economically the euro turned out to be very good for Germany, and with the euro crisis Chancellor Angela Merkel became the informal Queen of Europe. The new grammar of power reflects the difference between creditor and debtor countries; it is not a military but an economic logic. Its ideological foundation is 'German euro nationalism' - that is, an extended European version of the Deutschmark nationalism that underpinned German identity after the Second World War. In this way the German model of stability is being surreptitiously elevated into the guiding idea for Europe. The Europe we have now will not be able to survive in the risk-laden storms of the globalized world. The EU has to be more than a grim marriage sustained by the fear of the chaos that would be caused by its breakdown. It has to be built on something more positive: a vision of rebuilding Europe bottom-up, creating a Europe of the citizen. There is no better way to reinvigorate Europe than through the coming together of ordinary Europeans acting on their own behalf.

Europe in the Global Age

Europe's social model - its system of welfare and social protection - is regarded by many as the jewel in the crown. It is what helps to give the European societies their distinctive qualities of social cohesion and care for the vulnerable. Over recent years, however, the social model has come under great strain in many states within the European Union - unemployment, for example, remains stubbornly high. The resulting tensions have fuelled dissatisfaction with the European project as a whole, culminating in the rejection of Europe's proposed new constitution. Reform of the social model is therefore a matter of urgency. It has to go hand in hand with the quest to regenerate economic growth. The weaker performers in Europe over the past few years can learn a good deal from states that have coped more effectively. But more radical changes need to be contemplated in the face of the impact of globalization, rapidly increasing cultural diversity and changing

demography. The author argues that the traditional welfare state needs to be rethought. We have to bring lifestyle change into the heart of what welfare means. Moreover, environmental issues must be directly connected to other citizenship obligations. These innovations have to be made at the same time as Europe's competitive position is upgraded. This original and path-breaking book will rank alongside *Beyond Left and Right*, *The Third Way* and other works by Anthony Giddens that have helped reshape social and political thinking over recent decades.

Clint Eastwood's America

In this book, Markus Brunnermeier, Harold James, and Jean-Pierre Landau argue that the core problem with the Euro lies in the philosophical differences between the founding countries of the Eurozone, particularly Germany and France. But the authors also show how these seemingly incompatible differences can be reconciled to ensure Europe's survival. Weaving together economic analysis and historical reflection, *The Euro and the Battle of Ideas* provides a forensic investigation and a road map for Europe's future.

The EU after Brexit

Much attention has been paid to the ongoing and unpredictable Brexit negotiations between the EU and the UK, but much less on what the absence of the UK might entail for the remaining 27 EU Member States. This book explores the range of implications for the EU after Brexit, and whether it is likely to become stronger or weaker as a result. It reviews the different attitudes on the EU's future within both the member states and the individual EU institutions, and examines the impacts of Brexit on the composition of the EU institutions and on the balance of power between the member states. It also looks at linguistic and cultural impacts, the UK's wider legacy for the EU and possible changes in EU priorities. The author concludes that Brexit has reinforced the EU's unity in the short term, but that the EU will have to confront a number of key challenges if it is to be reinforced in the longer term. This book will appeal to practitioners, scholars and students interested in EU politics and integration in general, and Brexit in particular.

The Limits of Europe

Is the European Union (EU) in a state of crisis? Over recent years, a series of systemic and spontaneous challenges, including Brexit, the rise of Euroscepticism and the Eurozone and refugee crises, have manifested in landmark moments for European integration. First published as a special issue of the journal *Global*

Discourse, this edited collection investigates whether these crises are isolated phenomena or symptoms of a deeper malaise across the EU. Experts from across disciplines analyse and rethink the forces which pull Europeans together, as well as those which push them apart.

The Future of Europe

The European Union seems to have rescued its single currency, but it has not yet put an end to the crisis. Analysing domestic and European political reactions to the EU's polycrisis and assessing how EU institutions, national governments and broader publics have responded to a new era of politicization, The European Union beyond the Polycrisis? will be of great interest to scholars of European politics and the EU, as well as professionals working in EU institutions, national administrations and European advocacy groups. Europe Contested

Europe Contested analyses the failures and achievements of an astonishing era of economic advance and political chaos, from the First World War up to the present day. Beginning with the Great War, the book goes on to examine connections between the self-destruction of liberal democracy, market economics, and the international political and security framework in the interwar period. It then considers the mass politics that surrounded the glorification of new-style leaders Lenin, Stalin, Mussolini, and Hitler before moving on to explore the ways in which the interwar legacy was superseded post-1945. James examines the deceptive appearance of stability brought by a new convergence in European politics that focused around the market

and the principle of liberal democracy, and demonstrates how the impact of globalization and openness to migration and to destabilizing financial capital flows has eroded traditional politics and ended the stable left-right polarization at the core of the postwar order. This new edition has been thoroughly updated throughout, demonstrating also how an era of crisis is challenging Europe and its values. Supported by boxed case studies, illustrations, chronologies and an annotated bibliography, and focusing on Europe as a whole, it is the perfect introduction for students of Modern European History.

European Disintegration

This book accounts for whether and how the path of the European Union (EU) has developed towards potential disintegration. These questions have become particularly relevant since the outbreak of the debt crises in the Eurozone and the Brexit referendum. The author critically subverts theories of European integration and analyses the rise and fall of federations, empires and states in a comparative perspective. The most promising theory presented here indicates that Brexit is not likely to be followed by other member states leaving the EU. Nevertheless, the EU has been undermined from within as it cannot adequately address Eurosceptic dissatisfaction from both the left and right. This book is an essential read for everyone interested in the EU and its future.

Policy Design in the European Union

This edited collection addresses a paradox at the heart of the European Union: if it is a constantly enlarging empire of governance, how can almost thirty member states design policies as an administrative whole, whilst narrowly approaching all political issues from one economic point of view? The contributors to this collection approach this by studying knowledge production, policy formation and policy implementation in the union. Brexlit

Britain's vote to leave the European Union in the summer of 2016 came as a shock to many observers. But writers had long been exploring anxieties and fractures in British society – from Euroscepticism, to immigration, to devolution, to post-truth narratives – that came to the fore in the Brexit campaign and its aftermath. Reading these tensions back into contemporary British writing, Kristian Shaw coins the term Brexlit to deliver the first in-depth study of how writers engaged with these issues before and after the referendum result. Narrating European Society

Trenz introduces a sociological perspective on European integration by looking at different accounts of Europeanization as society building. He observes how Europeanization unfolds in ongoing practices and discourses through which social relations among the Europeans are redefined and re-embedded. The chapters describe how the project of European integration has been powerfully launched in postwar Europe as a normative venture that comprises polity and society building, how this project became ingrained in every-day life histories and experiences of the Europeans, how this project became contested and confronted resistances and, ultimately, how it went through its most severe crisis. A sociology of European integration is thus outlined along four main themes or narratives: first, the elite processes of identity construction and the framework of norms and ideas that carries such a construction (together with notions of European identity, EU citizenship, etc.); second, the socialization of European citizens, processes of banal Europeanism, and social transnationalism through everyday cross-border exchanges; third, the mobilization of resistance and Euroskepticism as a fundamental and collectively mobilized opposition to processes of Europeanization; and fourth, the political sociology of crisis, linked not only to financial turmoil but also, more fundamentally, to a legitimization crisis that affects Europe and the democratic nation-state.

European Identity in the Context of National Identity

This book provides an unprecedented insight into the multiple ways through which citizens of 16 countries connect their own national identity to European identity.

Leadership Styles in the European Council

Using the example of Werner Faymann, Dalia Grybauskaitė, Angela Merkel, Viktor Orbán and Mark Rutte, the book examines the impact that the European Council's environment has on leadership styles and the impact of leaders on the institution's decision-making during the financial and debt crisis, the Ukraine crisis, and the migration crisis (2010-2016). It presents domestic factors affecting the choice of leadership style nationally, finding cooperative styles are best suited to the European Council, as its structure relies on negotiated consensus. The European Council's environment has three effects on leadership styles and decision-making: socialisation towards cooperation, compromise making, and Europeanisation. The book provides an in-depth insight into how leaders behave among their peers behind closed doors.

Towards a Segmented European Political Order

This book makes a distinctive contribution to the crucial debate on the European Union (EU)'s present and future development. It systematically examines how the range of crises and challenges over the last decade have transformed the EU and relates those findings to the discussion of an increasingly differentiated EU. It argues that the post-crises EU shows clear signs of becoming a segmented political order with in-built biases and constraints. The book spells out the key features of such an order in ideational and structural terms and shows how it more concretely manifests itself in the EU's institutional and constitutional make-up and in how member states constrain and condition EU action. Different states impose different types of constraints, as is underlined through paying explicit attention to the Visegrád countries. This book will be of key interest

Differentiation and Dominance in Europe's Poly-Crises

Against the backdrop of a more differentiated European Union, this book discusses the relationship between differentiation and domination in the EU in relation to how it has been transformed through the financial and refugee crises, the COVID-19 pandemic, the Russian invasion of Ukraine, and in general, a more volatile and less rule-bound global context. In doing so, it assesses to what extent these adaptations represent significant change, generating new problems and challenges, or on the other hand, providing an opportunity for new solutions or even signalling a new approach to governance that can mitigate problems associated with domination. Differentiation is discussed not only from a legal perspective, but with special attention to structural and institutional arrangements, which includes patterns of path dependence and built-in biases. This book will be of key interest to scholars and students of public sector crisis management, international organisations, and EU politics and studies.

In Defence of Europe

Europe has not been so weak and divided for a long time. Buffeted by a succession of crises, it has shown a strong collective survival instinct but a poor capacity to deliver. In times when the tectonic plates are shifting and tension between global markets and national democracies is rising, can Europe hold together, under what terms and indeed for what purpose? The euro crisis has left big scars and is not over yet. Economic divergence has grown between and within countries, leading in turn to political fragmentation and the rise of populism. And growth remains slow, fragile, and uneven. Europe is in a bind: it is difficult to go forwards and scary to go backwards. In between, it is an unhappy and unstable state of affairs. Looking further afield, a more assertive Russia and an imploding neighbourhood may not even allow Europe the luxury to decline in grace. A convinced European and familiar with the world of Brussels, Loukas Tsoukalis is critical of the way Europe has handled its multiple crises in recent years. He addresses the key issues and difficult choices facing Europe today. Can Europe collectively manage globalization, combine growth with inclusive societies, and reconcile its apparent yearning for soft power with the often hard reality of the world outside? Individual countries cannot handle these challenges on their own. While knowing full well the difficulties in reaching a common European stance, Tsoukalis is also acutely aware of the consequences of failure.

Interregionalism and the European Union

Is the EU isolated within the emergent multipolar world? Concentrating on interregional relations and focussing on the European Union's evolving international role with regards to regional cooperation, this innovative book collects a set of fresh empirical analyses of interregional ties binding the EU with its Eastern and Southern neighbourhood, as well as with Asia, Africa and the Americas. The 25 leading authors from 5 continents have contributed original and diverse chapters and the book advances a novel theoretical 'post-revisionist' approach beyond both the Eurocentrism of 'Europe First' perspectives, as well as the Euroscepticism of those advocating to simply move 'Beyond Europe'.

Crisis and Renewal

This clear and comprehensive introduction to the European Union considers its development through the theme of crisis and renewal. John Van Oudenaren describes EU institutions and policies, both historically and as they relate to current events. He traces the renewal of the EU that was underway at the end of the 2010s following the euro, migration, and Brexit crises and the health, economic, and political crisis that subsequently hit the Union with unexpected force in the coronavirus pandemic of 2020–2021. Exploring how institutions and policies are adapting to unprecedented political, economic, and geopolitical challenges, the author focuses on two key EU priorities—digitization and the transition to a carbon neutral future. These, he

argues, are both intrinsic policy goals and the means by which the Union hopes to ensure its revitalization and its emergence as a “sovereign” power, taking its place alongside the United States and China as one of the big three players in global politics. Explaining the different theoretical perspectives used to understand the EU, the book gives students the tools they need to assess whether the Union is on a path to recovery and renewal.

The Politics of Crisis in Europe

An analysis of the repeated existential crises affecting the resilience of the European Union in the twenty-first century.

Theorising the Crises of the European Union

This book examines the relevance of integration theories for studying and analysing the crisis situations faced by the EU since 2009. Ten years on from the start of the ‘age of crisis’, it critically analyses the impact of the multiple crises’ context on the EU polity and questions the utility of integration theories for grasping the peculiarities of the particular crisis under study. Bringing together prominent scholars in EU studies, the volume constitutes an essential reference book on integration theories. Its contribution is twofold. First, it provides a comparative overview of classical integration theories for studying and analysing current crisis situations the EU faces. Second, the book connects theories to current debates through an in-depth discussion of recent crises that hit European integration since 2009, with a particular focus on the financial crisis, Brexit, refugee crisis, illiberal tendencies in some member states, and the Coronavirus pandemic. This book will be of key interest to scholars and students of European integration, European Union politics, political theory, and, more broadly, to European studies.

European Security Policy and Strategic Culture

With the Lisbon Treaty in place and the European Union increasingly involved in international crisis management and stabilization operations in places near and far, this volume revisits the trajectory of a European strategic culture. Specifically, it studies the usefulness of its application in a variety of circumstances, including the EU’s operations in Africa and the Balkans as well as joint operations with NATO and the United Nations. The contributors find that strategic culture is a useful tool to explain and understand the EU’s civilian and military operations, not in the sense of a ‘cause’, but as a European normative framework of preferences and constraints. Accordingly, classical notions of strategic culture in the field of international security must be adapted to highlight the specific character of Europe’s strategic culture, especially by taking the interaction with the United Nations and NATO into account. Though at variance over the extent to which security and defence missions have demonstrated or promoted a shared strategic culture in Europe, the authors reveal a growing sense that a cohesive strategic culture is critical in the EU’s ambition of being a global actor. Should Europe fail to nurture a shared strategic culture, its actions will be based much more on flexibility than on cohesion. Exploring the EU's Legitimacy Crisis

Exploring the EU's Legitimacy Crisis provides a profound analysis of the causes and the consequences of the EU's growing legitimacy problem. The prior permissive consensus in the EU has been markedly declining under persistent crisis conditions. Since the onset of the eurozone crisis the EU's governance has been narrowly driven by the semi-hegemonial leadership of Germany – manifesting itself in functionalist and technocratic policy reforms concentrated on strengthening economic governance coordination. Other crucial policy areas have been neglected as member states show decreasing solidarity and a growing emphasis on national interests in response to mounting external challenges. This book examines these developments in detail by scrutinising the EU's ability to maintain legitimacy through political leadership, democratic accountability and governance efficiency.

Living in an Age of Mistrust

Trust is a concept familiar to most. Whether we are cognizant of it or not, we experience it on a daily basis. Yet trust is quickly eroding in civic and political life. Americans' trust in their government has reached all-time lows. The political and social consequences of this decline in trust are profound. What are the foundations of trust? What explains its apparent decline in society? Is there a way forward for rebuilding trust in our leaders and institutions? How should we study the role of trust across a diverse range of policy issues and problems? Given its complexity, trust as an object of study cannot be claimed by any single discipline. Rather than vouch for an overarching theory of trust, *Living in an Age of Mistrust* synthesizes existing perspectives across multiple disciplines to offer a truly comprehensive examination of this concept and a topic of research. Using an analytical framework that encompasses rational and cultural (or sociological) dimensions of trust, the contributions found therein provide a wide range of policy issues both domestic and international to explore the apparent decline in trust, its impact on social and political life, and efforts to rebuild trust.

Europe Reset

In the last decade, the EU has been hit by a series of crises, most recently the UK's decision to leave the union following the Brexit referendum. In light of this, questions have been raised about the need to reform the whole model of European integration, with the aim of making the union more flexible and more accountable. In this book, Richard Youngs proposes an alternative vision of European co-operation and shows how the EU must re-invent itself if it is to survive. He argues that citizens should play a greater role in European decision-making, that there should be radically more flexibility in the process of integration and that Europe needs to take a new, more coherent, approach to questions of defence and security. In proposing this model for a 'reset' version of Europe, Youngs reinvigorates the debate around the future of Europe and puts forward a new agenda for the future of the EU.

In the decades that followed, this concept has come to encompass many different variations of legal rights, which this book seeks to investigate and assess. In this work, we envision the next decade with Europe 2020 strategy and review the fruits of the 2004 accession in Central and Eastern Europe. What has the Union achieved? Which policy areas are likely to change and how? How successful, and by what measure, has the accession of the 10 Member States in 2004 been? *Reviewing European Union Accession* addresses a wide range of issues, deliberately without any thematic constraints, in order to explore EU enlargement from a variety of perspectives, both scientific and geographical, internal and external. It is also helpful to students, researchers and professionals in the media sector since it combines hard facts with theoretical insight.

Revisiting the European Union as Empire
