#### The Biographic Register

Raised and educated in Rome, Juba II (48 BC- AD 23) was sent to uphold Roman interests in northwest Africa as ruler of the cliet kingdom of Mauretania. Together with his wife K'eopatra Selene, daughter of Marcus Anthonius and Kleopatra VII, he established a rich, multicultural environment at their capital, renamed Caesarea, where Egyptian, Hellenistic Greek and indigenous elements came together. Juba combined a reign of more than half a century with a career as a distinguished scholar and writer, producing an extensive collection of works and shaping Roman knowledge of the southern half of the known world, from the Atlantic coast of northwest Africa to India. This book explores the complex culture and legacy of the kingdom, with emphasis on Juba's scholarship and the world created by these two remarkable monarchs. This detailed and comprehensive study is not only the first examination in English of Juba's life and career, but the first critical analysis of the king both as an implementer of the Augustan political, artistic and intellectual programme and as a notable scholar.

What is commonly called the kingdom of Pontos flourished for over two hundred years in the coastal regions of the Black Sea. At its peak in the early first century BC, it included much of the southern, eastern, and northern littoral, becoming one of the most important Hellenistic dynasties not founded by a successor of Alexander the Great. It also posed one of the greatest challenges to Roman imperial expansion in the east. Not until 63 BC, after many violent clashes, was Rome able to subjugate the kingdom and its last charismatic ruler Mithridates VI. This book provides the first general history, in English, of this important kingdom from its mythic origins in Greek literature (e.g., Jason and the Golden Fleece) to its entanglements with the late Roman Republic. Duane Roller presents its rulers and their complex relationships with the powers of the eastern Mediterranean and Near East, most notably Rome. In addition, he includes detailed discussions of Pontos' cultural achievements—a rich blend of Greek and Persian influences — as well as its political and military successes, especially under Mithridates VI, who proved to be as formidable a foe to Rome as Hannibal. Previous histories of Pontos have focused almost exclusively on the career of its last ruler. Setting that famous reign in its wide historical context, Empire of the Black Sea is an engaging and definitive account of a powerful yet little-known ancient dynasty.

# The Whole Works of Roger Ascham, Now First Collected and Revised, with a Life of the Author; by ... Dr. Giles

Although scholars routinely state that the Iliad is an \"oral poem,\" since very near the time of its composition the great epic has circulated as a text stabilized in writing. Thus whether or not it is in some sense \"oral poetry,\" the Iliad undoubtedly has features that render it quite satisfactory to readers and reading. But the question of what these features might be has been difficult for modern Homeric scholarship even to frame, much less address, within the research paradigm of \"oral poetics.\" In Homer's Cosmic Fabrication Bruce Heiden delineates a new approach aimed at evaluating what the Iliad furnishes to readers that makes it comprehensible and engaging. His program conceptualizes the act of reading as a flexible repertoire of cognitive functions that a reader might deploy in collaboration with the poem's signs. By positing certain functions hypothetically and applying them to the poem, Heiden's experiments uncover the kind and degree of suitable \"reading material\" the poem provides. These analyses reveal that the trajectory of events in the Iliad manifests the central agency of one character, Zeus, and that the transmitted articulation of the epic into chapter-like \"books\" conforms to distinct narrative subtrajectories. The analyses also show, however, that the fixed sequence of \"books\" functions suitably as a design that cues attention to the major crises in the story, as well as to themes that develop its significance. The transmitted arrangement therefore furnishes an implicit cognitive map that both eases comprehension of the storyline and indicates previously unexplored pathways of interpretation. Through Homer's Cosmic Fabrication enthusiasts of the Iliad will gain enhanced understanding of the epic's poetic design and the philosophical rewards it offers to thoughtful study.

#### The Empire of the Black Sea

In Becoming a New Self, Moshe Sluhovsky examines the diffusion of spiritual practices among lay Catholics in early modern Europe. By offering a close examination of early modern Catholic penitential and meditative techniques, Sluhovsky makes the case that these practices promoted the idea of achieving a new self through the knowing of oneself. Practices such as the examination of conscience, general confession, and spiritual exercises, which until the 1400s had been restricted to monastic elites, breached the walls of monasteries in the period that followed. Thanks in large part to Franciscans and Jesuits, lay urban elites—both men and women—gained access to spiritual practices whose goal was to enhance belief and create new selves. Using Michel Foucault's writing on the hermeneutics of the self, and the French philosopher's intuition that the early modern period was a moment of transition in the configurations of the self, Sluhovsky offers a broad panorama of spiritual and devotional techniques of self-formation and subjectivation.

This book proposes that the idea of the Jews in European cultures has little to do with actual Jews, but rather

It will stir up controversy around Christian-Jewish cultural interaction; the representation of otherness in European arts and folklore; modern Jewish experience; and Russian literature and culture.

#### The Mahabharata, Volume 3

Homer and the Poetics of Hades offers a new and unique approach to the Iliad and, more particularly, the Odyssey through an exploration of the role and function of the Underworld as a poetic resource permitting an alternative perspective on the epic past. By portraying Hades as a realm where vision is not possible, Homer creates a unique poetic environment in which social constraints and divine prohibitions do not apply, resulting in a narrative which emulates that of the Muses but which at the same time is markedly distinct from it. In Hades experimentation with, and alteration of, important epic forms and values can be pursued with greater freedom, giving rise to a different kind of poetics: the 'poetics of Hades'. In the Iliad, Homer offers us a glimpse of how this alternative poetics works through the visit of Patroclus' shade in Achilles' dream. The recollection offered by the shade reveals an approach to its past in which regret, self-pity, and a lingering memory of intimate and emotional moments displace an objective tone and traditional exposition of heroic values. However, the potential of Hades for providing alternative means of commemorating the past is more fully explored in the 'Nekyia' of Odyssey 11: there, Odysseus' extraordinary ability to see the dead in Hades allows him to meet and interview the shades of heroines and heroes of the epic past, while the absolute confinement of Hades allows the shades to recount their stories from their own personal points of view. The poetic implications are significant, since by visiting Hades and listening to the stories of the shades Odysseus, and Homer with him, gain access to a tradition in which epic values associated with gender roles and even divine law are suspended in favour of a more immediate and personally inflected approach to the epic past. As readers, this alternative poetics offers us more than just a revised framework within which to navigate the Iliad and the Odyssey, inviting as it does a more nuanced understanding of the Greeks' anxieties around mortality and posthumous fame.

#### The Biographic Register

Textual Permanence is the first book to examine the influence of the Roman epigraphic tradition on Latin elegiac poetry. The frequent use of invented inscriptions within the works of Rome's elegiac poets suggests a desire to monumentalise elements of the poems and the authors themselves. This book explores inscriptional writing in the elegies of Catullus, Propertius, Tibullus and Ovid, showing that whenever an author includes an inscription within a poem, he draws the reader's attention beyond the text of the poem to include the cultural contexts in which such inscriptions were daily read and produced. The emphases that these inscriptions grant to persons, sentiments and actions within the poems are reflections of the permanence that real-life inscriptions grant to a variety of human efforts. These poetic inscriptions provide unique windows of interpretation to some of Rome's most significant and influential poems. Teresa Ramsby traces an important relationship between the Roman tradition that honoured individual participation in Roman politics, and the way that elegiac poetry was early applied in Rome to the same activity. In the course of the book she offers fresh interpretations of poems that have been analysed by a host of scholars.

The defeat was a heavy blow to both Rome's military and its pride. Though the disaster was ruthlessly avenged soon afterwards, later attempts at conquering the Germans were half-hearted at best. Four Days in September thoroughly examines the ancient sources and challenges the hypotheses of modern scholars to present a clear picture of the prelude to the battle, the fighting itself and its aftermath.
