Autonomous Vehicles

This edited book aims to address challenges facing the deployment of autonomous vehicles. Autonomous vehicles were predicted to hit the road by 2017. Even though a high degree of automation may have been

achieved, vehicles that can drive autonomously under all circumstances are not yet commercially available, and the predictions have been adjusted. Now, experts even say that we are still decades away from fully autonomous vehicles. In this volume, the authors form a multidisciplinary team of experts to discuss some of the reasons behind this delay. The focus is on three areas: business, technology, and law. Physical activity has far-reaching benefits for physical, mental, emotional, and social health and well-being for all segments of the population. Despite these documented health benefits and previous efforts to promote physical activity in the U.S. population, most Americans do not meet current public health guidelines for physical activity. Surveillance in public health is the ongoing systematic collection, analysis, and interpretation of outcome-specific data, which can then be used for planning, implementation and evaluation of public health practice. Surveillance of physical activity is a core public health function that is necessary for monitoring population engagement in physical activity, including participation in physical activity initiatives. Surveillance activities are guided by standard protocols and are used to establish baseline data and to track implementation and evaluation of interventions, programs, and policies that aim to increase physical activity. However, physical activity is challenging to assess because it is a complex and multidimensional behavior that varies by type, intensity, setting, motives, and environmental and social influences. The lack of surveillance systems to assess both physical activity behaviors (including walking) and physical activity environments (such as the walkability of communities) is a critical gap. Implementing Strategies to Enhance Public Health Surveillance of Physical Activity in the United States develops strategies that support the implementation of recommended actions to improve national physical activity surveillance. This report also examines and builds upon existing recommended actions.

Bestrafte Innovation?

Technology is an important part of our everyday lives. Whether we ask Alexa to start the coffee machine, or check our phones for the traffic report, we increasingly interact with technology. As much as we may enjoy and rely upon technology, it is not without its challenges, including the inability of the law to keep pace with technological developments and the ethical issues that arise. For example, tort law is impacted by technology; the proliferation of drones requires a new look at the law of trespass, and video Zoom meetings can impose direct liability on employers, for example. Social media supports an increasing share of all advertising and endorsements and is subject to regulation, of which influencers are often not aware. Global advertising expenditures on various internet and social media platforms also drives the need for a change in right of publicity law. In the United States, the right of publicity is governed by state rather than federal law, so there is no uniform approach. One part of the book includes a survey of the law of each US state, and

proposes a new federal statute. Although most of the examples are drawn from the US, the issues raised are fully international in scope and relevance. This book will appeal to legal practitioners trying to manage new technology issues facing their clients; academics teaching students how the law is changing, and needs to continue to change, as technology develops; and teachers and researchers in business and management schools, needing to address technology and governance issues.

Law and Technology

Rich Pickings: Creative Professional Development Activities for University Teachers offers both inspiration and practical advice for academics who want to develop their teaching in ways that go beyond the merely technical, and for the academic developers who support them. Advocating active engagement with literary and nonliterary texts as one way of prompting deep thinking about teaching practice and teacher identities, Daphne Loads shows how to read poems, stories, academic papers and policy documents in ways that stay with the physicality of words: how they sound, how they look on the page or the screen, how they feel in the mouth. This book does not attempt to construct a single, coherent argument but rather to indicate a range of good things to choose from. Readers are encouraged to explore the overlaps and the gaps.
